1 - Consideration and action on a Final Plat of Acoma Court dated December 19, 2016; a property generally located approximately 1,650 feet west of Reems Road, bounded by West Custer Lane to the north, the Calibre Academy of Surprise to the east, West Acoma Drive to the south, and the Legacy Parc Planned Area Development (PAD) to the west - APPROVED

4 - Consideration and action on the meeting minutes of January 3, 2017 Regular City Council Work Session and Regular City Council Meeting - APPROVED

Council Member Hall made the motion to approve the consent agenda excluding item #2. Council Member Tande seconded the motion. Seven yes votes, motion carried.

5 - Consideration and action pertaining to the annexation of approximately 203.28 acres located generally between Waddell Road, Cactus Road, Cotton Lane and 175th Avenue; Ordinance # 2017-01 - APPROVED

Community Development Director, Eric Fitzer commented he would be presenting items 5-9, he recommended continuing items 6-9 to the February 7, 2016 Council Meeting.

Council Member Remley - Questioned the property financial impacts of the annexation.

Council Member Winters - When the City annexes property, the City has to support this property with City services.

Council Member Tande - Questioned operating funds on the powerpoint.

Council Member Remley - These rooftops do cost money, question is rooftop or businesses coming first. No matter which way we go there is a cost.

Council Member Tande - I like the idea of taking on these county islands. By annexing, they will have to follow our guidelines.

Council Member Williams made the motion to approve Ordinance 2017-01. Council Member Hall seconded the motion. Seven yes votes, motion carried.

6 - Consideration and action pertaining to rezoning approximately 181 acres of property generally located between Cotton Lane, 175th Avenue, Waddell Road and Cactus Road from Residential Ranch (RR) to Residential Medium Density 6 DU/Acre Planned Unit Development (RM-6 PUD), Residential Medium Density 9 DU/Acre Planned Unit Development (RM-9 PUD), Residential High Density Planned Unit Development (RH PUD) with Flex Zone, Regional Commercial Planned Unit Development (CR PUD) with and without Flex Zone; and from Residential High Density Planned Unit Development (RH PUD) to Residential Medium Density 9 DU/Acre Planned Unit Development: Ordinance # 2017-03 - CONTINUED TO

FEBRUARY 7, 2017 REGULAR CITY COUNCIL MEETING

Public Comments: Lauralie Berkin - Lives in Sara Ann Ranch, on the Citrus Road side. Curious about the box on 175th Avenue and Sweetwater, will create more traffic in this areas and with stop signs.
